"CARD CHECK" MAY BE OUT, EFCA REMAINS DANGEROUS

The Senate is planning to drop the "card check" provision from the Employee Free Choice Act ("EFCA"). Although the anticipated rewrite represents a major victory for advocates of employee and management rights, the decision to jettison the "card check" provision may turn out to be a political calculation to force passage of equally troubling proposals that change the way workers organize. EFCA could pose more of a threat than ever before.

Early indications are that an expedited union election schedule will replace EFCA's "card check" provision. Presently an election typically is conducted six to eight weeks after the union files a petition with the National Labor Relations Board. During the pre-election period both the employer and the union utilize the time to fully inform the employees about the pros and cons of unionization. The reported expedited schedule of up to ten days would cut this time significantly, and significantly diminish the ability of employers to notify workers of issues associated with union membership such as paying dues and strikes.

EFCA's two key remaining provisions – requiring mandatory binding interest arbitration for first contracts and increased penalties for companies that violate labor law – for now remain unaltered by the expected compromise. EFCA changes the fundamental principles underlying private sector collective bargaining. Currently, the employer and the union are free to negotiate an agreement without government interference or intrusion into the process. Under EFCA, as proposed, if the parties cannot reach agreement on first-contract with a union within 120 days after bargaining begins, a government-appointed arbitrator will be empowered to impose employment terms upon the business and its employees for a two year period. Employees may never get a chance to vote on an agreement. Additionally, the bill imposes a civil penalty of up to \$20,000 for each violation by the company that is willful

or repetitive.

There is also the troubling prospect that even if the Senate passes EFCA sans "card check," the House can still pass EFCA with "card check" thereby enabling the Senate simply to include the provision during conference. With or without the "card check" provision, EFCA raises the stakes of a successful union campaign. Any iteration of the Employee Free Choice Act would be disastrous for our economy and our record unemployment rates. The fight against the so-called Employee Free Choice Act must continue.

HEAT WAVE PRODUCES NEED FOR HEAT ILLNESS PREVENTION

The national weather forecast predicts that temperatures will exceed 100 degrees in many regions of California this week. It is important that employers take action to protect their employees from heat illness as required by the California Heat Illness Prevention Standard. There are four basic requirements under the new standards:

- 1) Provide heat illness training to all employees and supervisors:
- 2) Provide enough fresh water for each employee to drink at least 1 quart per hour and encourage them to do so;
- 3) Provide access to shade for at least 5 minutes of rest when an employee believes he or she need a preventative recovery period (There are additional shade requirements-not just when an employee requests it);
- 4) Develop and implement written procedures for complying with the heat illness prevention standard.

Cal OSHA indicates that employers are meeting the first three requirements, but most of the citations this year have been for failure to develop and implement written procedures for complying with the standards. These procedures must be available to employees and representatives of Cal/OSHA upon request. The procedures specify how the employer will comply with the heat illness standards, how to respond to heat illness symptoms, how emergency services will be provided and how clear and precise directions to the worksite will be provided to emergency responders in case of an emergency. Compliance with the heat illness standards will reduce the potential for heat illness and facilitate prompt treatment of employees should a heat emergency situation arise.

PROPONENT GROUP URGES STAKEHOLDERS TO SUPPORT, COMMENT ON NLGMA

The current proponent group for the National Leafy Greens Marketing Agreement (NLGMA) in anticipation of public hearings later this year, is planning a series of informational Webinars beginning next month. Instructions on how to sign-up and dates for the Webinars will be made available in subsequent editions of Spotlight. In the mean time, Western Growers is encouraging all interested parties to read and review important information about the agreement at www.nlgma.org.

The proponents (Western Growers, United Fresh Produce Association, Produce Marketing

Association, Georgia Fruit and Vegetable Association, Georgia Farm Bureau, Texas Vegetable Association, Arizona Farm Bureau, Leafy Greens Council, California Farm Bureau, Growers Shipper Association of Central California, Imperial Valley Vegetable Growers Association and the California Leafy Green Products Handler Marketing Agreement) submitted the proposal to USDA on June 8, to launch an open and transparent process that engages the leafy greens industry in the development and implementation of a NLGMA through the publication of a federal register notice, solicitation of comments and public hearings. Western Growers expects the USDA will publish a notice of public hearings in the federal register sometime in August with public hearings taking place across the country 30 days thereafter.

To build awareness and solicit feedback proponents have established a publicly available Web site that has copies of the DRAFT agreement along with other information including a copy of the request letter to USDA, justification and some frequently asked questions. Western Growers is encouraging all interested parties to visit this Web site here and submit comments, suggestions or questions to the proponents.

In addition, the Web site also offers interested parties an opportunity to sign on as supporters of the NLGMA by filling out an on-line form, here. Western Growers strongly encourages it's member companies to formally indicate their support for the national leafy greens marketing agreement. We are working with other proponents across the country to develop a list of companies that favor a national agreement.

HOUSE AG COMMITTEE QUESTIONS NEED FOR FDA ON THE FARM

The House Agriculture Committee chairman Collin Peterson (D-MN) held a hearing today in Washington, D.C. to listen to concerns facing agriculture including concerns raised by the Food Safety Enhancement Act (HR 2749) that was approved by the Energy and Commerce Committee on June 17, and which has been slated for a House floor vote before the August 8 recess.

Peterson cannot support the bill in its current form and said that if the bill is not fixed, he will hold a mark up of the bill in his Committee and report the bill out of his Committee unfavorably. Such action would make it extremely difficult for the bill to go to the floor for a vote. Among those testifying in the first panel was Drew MacDonald, vice president national quality systems for Taylor Farms. MacDonald spoke on behalf of Western Growers, United Fresh Produce Association, and the Produce Marketing Association, and talked extensively about the costs and inefficiency associated with the lack of a consistent and agreed-upon standard for food safety audits. He also talked about the need for strengthened FDA-industry partnership and used the California Leafy Greens Marketing Agreement as the model example how industry came together to design and implement a program of good agricultural practices and science and risk-based, commodity-specific guidelines for food safety on farms. Moreover, he spoke to the need for more FDA accountability and use of industry expertise during foodborne illness outbreaks.

Representatives of the Farm Bureau Federation, American Meat Institute, National Cattlemen's Beef Association, the National Farmers Union and an owner/operator of an

organic farm in Maryland, also testified and expressed concerns about user fees, food safety plans, recalls, quarantines and record-keeping policies outlined in the legislation. Also testifying was Carol Tucker-Foreman of the Consumer Federal of America, who said she supported the bill but would like to see changes made.

"Directing the Food and Drug Administration to tell farmers how to farm will make food more expensive, it will threaten our food security, it will increase our reliance on foreign food — it will not make our food supply safer," said Robert W. Goodlatte of Virginia, the Agriculture panel's ranking Republican.

Representative Jim Costa (R-CA) convened the second panel in Peterson's stead questioning regulatory officials Jerold Mande, deputy under secretary for food safety, USDA; Cindy Smith, acting under secretary for marketing and regulatory programs, USDA, and Mike Taylor, senior advisor to the FDA commissioner. The Committee members wanted to know if they had any reason to believe the FDA would do a better job than the USDA when it came to ensuring good food safety practices on farms and questioned the ability of FDA and USDA to communicate effectively with one another under shared responsibility, as designated in the current food safety bill. Taylor assured the Committee that FDA and USDA are committed to working together and communicating effectively on food safety issues.

ARIZONA'S LARGEST RETAILER BANKRUPT, WG HERE TO HELP

Bashas', Arizona's largest grocery store retailer with 158 stores, filed for bankruptcy protectio announced it would close 10 stores by July 21. Produce creditors have contacted Western G assistance.

The amount of produce debt covered by the PACA Trust provision reach \$5 million, and expethat it could be paid. In fact, Bashas' has informed its creditors that it hopes to reorganize an bankruptcy within three months.

The firm blamed the national credit crisis and slow growth in Arizona for its financial woes. T announced that closing 10 under-performing stores and other cost-cutting measures will allow 1,000 jobs.

Bashas' has obtained \$45 million in financing to fund ongoing operations. Financial experts r during the bankruptcy period, Bashas' may be able to negotiate more favorable terms with crimore easily abandon store leases and other contracts.

With news of the bankruptcy circulating, produce creditors began to surface contacting PACA Western Growers to determine the steps they should take. Because of the PACA Trust provi produce creditors first in line in bankruptcy proceedings, Oliveri said every indication is that a produce debt could be paid.

OBAMA ADMINISTRATION GIVES BRIEFING ON FOOD SAFETY

In a White House briefing today, recommendations made by a Food Safety Working Group created in March by President Obama were announced by Vice President Joe Biden, Health and Human Services Secretary Kathleen Sebelius and USDA Secretary Tom Vilsack. The Administration emphasized its focus on both preventing food contamination and enhancing the ability of the food safety system to respond to events such as an adulterated product in the market stream or an actual outbreak. The Administration issued new measures across the egg, beef and produce sectors.

With regard to produce, FDA will issue commodity-specific draft guidance by the end of July for the reduction of microbial contamination in production and distribution of tomatoes, melons and leafy greens across the United States. FDA will seek public comment on this guidance over the next two years with a view to mandatory adoption through regulation at the end of that time. FDA has already conveyed its support of the development of a national Leafy Greens Marketing Agreement, and we expect the FDA guidance to be informed by the experience of the produce industry, particularly the leafy green, tomato and melon sectors, which have, or are, developing food safety production standards. These guidelines as well as overarching verification programs such as the one associated with the leafy greens marketing agreements provide a foundation for FDA to complete their work in a fashion that both improves food safety and engages the expertise and experience of the fresh produce industry.

Other announcements today included:

- Improvements to food safety system's response and recovery efforts through strengthened coordination between local, state and federal food safety authorities, industry guidance on product tracing systems, and the establishment of an incident command system to address outbreaks of foodborne illness.
- The use of new technology to deliver individual food safety alerts to consumers.
- Improved accountability through the creation of a Deputy Commissioner for Foods who will be empowered to restructure and revitalize FDA's activities.
- The targeting of salmonella contamination by developing tougher standards to protect the safety of eggs, poultry, and turkey.
- Reducing the threat of E. coli contamination by stepping up enforcement in beef facilities.
- A continuing role for the Food Safety Working Group to address cross cutting issues and ensure increased coordination on food safety across the U.S. government.

ARIZONA LEGISLATURE ACTS IN SPECIAL BUDGET SESSION

The Arizona Legislature convened yesterday for the special session called by Governor Jan Brewer after she issued a series of vetoes last week on many of the budget bills that were sent to her on the eve of a new fiscal year as a potential government shutdown loomed. While she signed the general appropriations bill to keep government agencies operating, she line-item vetoed the payments to school districts which are supposed to occur by July 15th. In addition, her veto of several supplemental bills put the state in jeopardy of losing federal stimulus monies for education and healthcare.

Fortunately, last night the Legislature was able to put together a bipartisan plan that restores school funding and puts Arizona in compliance to receive the stimulus money. The Legislature adjourned after passing these bills and has committed to coming back to finish the special session once an agreement is reached. The vetoes last week leave the state with a \$2 billion deficit going forward.

Even though the Governor's office had expressed support for the Budget Reconciliation, Efficiency and Consolidation (BREC) Plan for the Department of Agriculture (ADA), it too was vetoed as part of larger supplemental budget bills. As it stands today, ADA has to find a way to cut \$1 million out of its general fund budget without the tools and efficiencies that were provided through the BREC Plan.

It is still unknown when the Legislature will come back to finish the budget though indications are that something will be done in August. WG staff will continue to work

BREWER VETOES BUDGET, CALLS SPECIAL SESSION

As reported yesterday, the Arizona Legislature passed the FY 2010 budget early Wednesday morning. However, shortly after passage, Governor Jan Brewer vetoed several budget bills and line-item vetoed portions of the general appropriations bill. She also called the legislature into a special session commencing Monday, July 6, to address the budget issues.

Her vetoes included two bills that had portions of the Budget Reconciliation, Efficiency, and Consolidation (BREC) Plan for the Arizona Department of Agriculture. The portions vetoed included key components to the plan including the ability of the Ag Advisory Council to appropriate funds within ADA and the sale of the State Ag Lab Building. The bill she signed included general appropriations, and in that legislation the ADA's General Fund allotment is set to decrease by more than \$1 million.

Last night, the North Carolina federal district court judge assigned the complaint seeking an injunction blocking suspension of the Bush H-2A rules granted that injunction.

PRODUCE ASSOCIATIONS PETITION USDA FOR A NATIONAL LEAFY GREENS MARKETING AGREEMENT

Yesterday, a proponent group, including the United Fresh Produce Association, Produce Marketing Association, Georgia Fresh Vegetable Association, Georgia Farm Bureau, Texas Vegetable Association, Arizona Farm Bureau, Leafy Greens Council, California Farm Bureau, California Leafy Greens Marketing Agreement, Grower-Shipper Association of Central California and Western Growers sent a letter to the U.S. Department of Agriculture (USDA) formally requesting the agency begin the process necessary to establish a national marketing agreement for leafy greens (NLGMA).

"This marketing agreement is an excellent example of our fresh produce associations working together for the good of the industry," said Charles Hall, executive director of the Georgia Fruit and Vegetable Growers Association in a press releases issued by the proponent group yesterday. "The 'proposed agreement' guarantees all parties - growers, packers, handlers, manufactures and end-users - are at the table as we move forward to ensure the food safety of leafy greens for the consumer."

WESTERN GROWERS HAILS REINTRODUCTION OF AGJOBS

Western Growers officials today are applauding California Senator Dianne Feinstein (D-CA) and Congressmen Howard Berman (D-CA) and Adam Putnam (R-FL) for reintroducing AgJOBS in the Senate and House of Representatives, respectfully.

"We commend Senator Feinstein and Congressmen Berman and Putnam for showing tremendous political courage. The current economic crisis has only magnified what our industry has been saying for years; despite record unemployment in parts of this country, we are not seeing American workers willing to take jobs as field laborers," said Western Growers President and CEO Tom Nassif.

AgJOBS is a two part bill. The first part would allow workers to qualify for temporary resident status provided they can prove they were substantially employed in U.S. agriculture during the past two years. Such workers would eventually be permitted to apply for permanent residency status provided they can prove that they have performed extensive agricultural work in the U.S. after the bill's enactment. The second part restructures and reforms the current H-2A temporary agricultural worker program.

"This is more than an immigration issue; it's an economic issue," Nassif said. "California agriculture is a \$37 billion industry. Without the passage and implementation of AgJOBS, California and the nation will continue to export farms along with the field jobs and the three to four upstream and downstream jobs that are created in the economy."

WESTERN GROWERS STANDS WITH HOUSE REPUBLICANS AGAINST EFCA

Western Growers Past Chairman Steve Patricio and President and CEO Tom Nassif joined U.S. House of Representatives Republicans today at a press conference on Capitol Hill to discuss the impact the Employee Free Choice Act (EFCA), if passed, would have on the agricultural industry and rural economies.

The press conference was called by Rep. Frank Lucas (R-OK), ranking member; Rep. Mike Pence (R-IN), Republican Conference chairman; Rep. Kevin McCarthy (R-CA), Republican chief deputy whip; Rep. Buck McKeon (R-CA), ranking member, Committee on Education & Labor; and Chuck Conner, president & CEO, National Council of Farmer Cooperatives.

With the media on hand, Nassif and the other panelists made the case against EFCA from agriculture's point of view.

"Protection of the secret ballot is fundamental to our cause, and we will fight to ensure the basic American right of casting a ballot in private is defended. The mandatory arbitration provisions of the bill threaten the economic growth and job creation in agriculture and are also unacceptable," Nassif said. "While field workers would not be subject to EFCA, we must remember that agricultural employment reaches far beyond the farm gate. Many of the workers in the agricultural industry would be subject to the provisions of this legislation. EFCA could adversely impact every segment of the agricultural supply chain, putting further pressure on the ability of farms to continue to operate in the United States."

"I strongly support a worker's right to vote his choice under the most basic right of a democracy; a secret ballot," said Patricio. "I also strongly support that worker's right and the right of his employer to negotiate in good faith for the wages and conditions they know and understand best. This is a bad piece of legislation and an insult to our democratic principles. This bill should not be allowed to see the light of day."

Western Growers is a founding member of ADW (www.coalitionforagriculture.org), which is active in the leadership of the broader coalition working to defeat the EFCA. The bill was introduced in both Houses of Congress in March 2009; however, a number of Senators have reconsidered their support as constituents have become more vocal about the potential threat to the secret ballot in union elections.

HOUSE AG COMMITTEE DISCUSSES FOOD SAFETY

Today the House Subcommittee on Horticulture and Organic Agriculture held food safety hearings to review food safety standards for horticulture and organic agriculture.

Panelists included: Dr. David Acheson, associate commissioner for foods, U.S. Food and Drug Administration; David Shipman, acting administrator, Agricultural Marketing Service, U.S. Department of Agriculture; Joe Pezzini, chief operating officer, Ocean Mist Farms, Castroville, Calif.; Ron Ratto, president, Ratto Bros., Inc., Modesto, Calif.; Dr. Robert F. Stovicek, president and chairman of Primus Group, Inc., Santa Maria, Calif.; and other industry stakeholders from Maryland, Ohio and South Carolina, respectively.

Rep. Dennis Cardoza (D- CA), chairman of the subcommittee, opened the hearing referencing California's efforts toward food safety saying producers here have, "implemented a solid first step toward food safety with the leafy greens marketing

agreement," following the E. coli outbreak in spinach in 2006.

As the subcommittee prepares to take action on food safety legislation, possibly as early as this summer, Rep. Jim Costa (D- CA) recognized that the food produced in this country is the safest in the world, but conceded that does not mean there isn't room to improve the food safety efforts here. He also said imported standards must meet domestic standards.

During the hearing Pezzini spoke about the success of the California Leafy Greens Handlers Marketing Agreement and how it could be a viable model nationally to enhance food safety. Ratto echoed Pezzini's remarks noting the, "LGMA food safety practices have elevated our food safety practices to a much higher level."

During the question and answer period, there was a clear emphasis by the members in using USDA for inspection purposes. There was also a desire shared by all parties, members and panelists alike, for greater collaboration, though there has been progress made of late, between USDA and FDA on matters of food safety.

FOOD SAFETY WORKING GROUP CONVENES

The Listening Session included <u>remarks</u> from Secretary of Health and Human Services Kathleen Sebelius and Secretary of Agriculture Tom Vilsack, the co-chairs of the Working Group. Those remarks were followed by smaller group breakout sessions with Administration and Congressional staff and stakeholders to discuss how to address major challenges and opportunities in food safety.

"A new system will depend upon good data. It must engage industry at every level and it must provide for high-quality inspections and effective enforcement by public agencies. When outbreaks do occur, we must all respond quickly, both to protect public health and to speed the recovery of affected industries," said Health and Human Services Secretary Kathleen Sebelius

"The key to a functioning food safety system is preventing foodborne illness. That means robust standards and sufficient authorities to prevent illnesses from occurring. Both FDA and USDA have embraced this principle and we must have a consistent approach," said USDA Secretary Tom Vilsack.

WESTERN GROWERS HEARS FROM ADMINISTRATION, FOOD SAFETY A PRIORITY

Today, Western Growers participated in a conference call hosted by President Barack Obama's Food Safety Working Group, which is headed up by the Secretaries of U.S. Department of Agriculture (USDA) and Health and Human Services (HHS). This group is scheduled to counsel the president in June on administrative, regulatory, and legislative options as it relates to food safety on a national level.

The overarching theme of the call was that the federal government has a renewed commitment to coordinate with state agencies and the industry to develop federal food safety policies. A steering group, comprised of representatives from agencies ranging from USDA to the Office of Management and Budget (OMB), and others, will report back to the White House its recommendations in June.

According to today's briefing, the steering group is looking to make recommendations in three areas, which include:

- --Administrative actions that could be taken now to address food safety needs.
- --Regulatory actions using current authority that could be taken now through notice and comment rule making, and
- --Legislative steps that the Administration could support in Congressional bills (current or not yet introduced)

With "prevention" being the group's primary concern, as it relates to limiting food borne illnesses, it identified five areas of work:

- --Setting and verification of appropriate food safety standards.
- --Strengthening early warning through better risk assessment and detection
- --Implementing risk-based inspection and enforcement
- --Rapid outbreak identification and response
- -- Necessary Infrastructure

This group will be seeking public input on its Web site, which will be unveiled next week (www.foodsafetyworkinggroup.gov). Western Growers will be working closely with this group throughout the process to ensure the industry's voice is heard. Meanwhile, Western

Growers continues to work with officials at USDA and industry counterparts to take the leafy greens marketing agreement model, which is in place and thriving in Arizona and California, nationally. This preventative approach to food safety could prove to be a valuable model as national food safety policies are discussed and enacted.

GOV. SCHWARZENEGGER URGES CONGRESS TO END MEXICAN TRADE DISPUTE

Yesterday, Governor Arnold Schwarzenegger sent a letter to the California Congressional Delegation urging them to take action to end the current trade dispute with Mexico. Mexico has imposed \$2.4 billion in tariffs on a host of U.S. products in retaliation to Congress' de-funding of a pilot cross-border trucking program. Under the program, a limited number of Mexican trucks were able to travel beyond the 20-25 mile commercial zone at the border to deliver goods to their points of destination within the United States. The program was in accordance with the provisions of the North American Free Trade Agreement as well as the 2000 ruling by the World Trade Organization.

Congress effectively ended the program when it de-funded it, leading Mexico to slap significant tariffs ranging from 10-45 percent on many items including lettuce, strawberries, onions, grapes and pears.

In the letter, Gov. Schwarzenegger wrote: "In this time of economic distress, when more than one in 10 Californians are out of work and the repercussions are felt throughout our great state, we must do all we can to boost trade with our international partners – not stifle it. And yet I am afraid that the prohibition recently placed on Mexican truckers will do exactly that, with the result being markets functionally closed to our goods and thousands more Californians unemployed at a

time when we can quite literally least afford it."

He added that the drought and economic crisis "have already punished the agricultural community of California severely. Now this community faces even more job losses and economic devastation because the United States has acted voluntarily to violate its commitments under the North American Free Trade Agreement."

Responding to the claims that Congress de-funded the program for safety reasons, Schwarzenegger said "we must not allow safety to serve as a smokescreen for protectionist measures...The termination of the pilot program has not made U.S. roads safer, but it has hurt the economy of California and the nation as a whole."

He noted the ongoing efforts to address this issue but asked the California representatives to "immediately take the lead in restoring a program to allow Mexican trucks to safely operate within the United States and allow Mexico to remove the retaliatory tariffs it has put in place."

NEW YORK TIMES GETS FIRST-HAND LOOK AT LGMA AUDIT

Yesterday, New York Times food and beverage reporter, Andrew Martin, and his photographer traveled to Huron with California Leafy Green Products Handler Marketing Agreement's (LGMA) Executive Director Scott Horsfall and experienced a standard food safety audit at a lettuce field during harvest.

Earlier this month, Martin investigated the audit protocols and procedures at the Peanut Corporation of America plant in southwest Georgia and published a front page story March 6, "Food Problems Elude Private Inspectors," in which he took those inspections to task following the recent outbreak of salmonella in peanut paste processed at the Georgia facility.

Martin, who interviewed Hank Giclas earlier this year for a story about irradiation of leafy greens, contacted Western Growers' communication department two weeks ago to find out what actions the spinach industry took after the 2006 outbreak of E. coli and learned about the rapid response remedy that became the LGMA. Western Growers offered to put him in touch with the LGMA so he could see the audit process for himself. In a phone call to Western Growers' Tom Nassif, following the four-hour audit, the reporter expressed his satisfaction with the thoroughness of the procedure and the cooperation he received from grower. During the telephone interview, Nassif told the story of how the California LGMA came to be and outlined the efforts Western Growers is currently spearheading on a national level: bringing together a proponent group and drafting a proposal to the USDA for a national leafy greens marketing agreement. Martin asked if this model could be expanded and used for other commodities, to which Nassif replied, "Yes, it may serve as a model for others and we are working to ensure it is incorporated into food safety legislation

that is currently being discussed in Washington."

Martin said he will continue his research through next week and is not sure at this point exactly when the story will be published. He seemed very satisfied with the information and the openness shown him by Western Growers and the LGMA.

HOUSE APPROVES SAN JOAQUIN RIVER RESTORATION AGREEMENT

After decades of negotiations, legal challenges and debate, the U.S. House of Representatives passed a bill Wednesday that basically ratifies an agreement reached among stakeholders to restore the San Joaquin River. But the massive public lands management plan included many other projects as well.

The Omnibus Public Land Management Act of 2009 will settle a 1988 lawsuit filed by the Natural Resources Defense Council. It authorizes river channel improvements and other work needed below Friant Dam to restore full river flows and a salmon run by 2013. Ultimately the bill will take water from agriculture to restore the San Joaquin River. This first year, 40,000 acre feet have been allocated for the river restoration project with more water being used in coming years. Western Growers did explore the possibility of delaying that allocation because of the current drought conditions, but that apparently is impossible under the terms of the settlement.

The bill is loaded with many other projects outside of California which caused some members of Congress, mostly Republicans, to vote against it. Among the 140 "No" votes were San Joaquin Valley legislators George Radanovich, R-Mariposa, and Devin Nunes, R-Visalia. Radanovich was in favor of the San Joaquin River restoration project but opposed to some of the other projects included in the bill. Nunes said the bill's provision diverting San Joaquin River water from farms to environmental protection "will ensure higher unemployment" in the Valley.

Valley Democrats, including Reps. Dennis Cardoza, D-Merced, and Jim Costa, D-Fresno, voted for the legislation.

The bill was previously passed by the Senate and now it moves to President Obama for his expected signature.

SPECTER PLEDGES TO VOTE AGAINST EMPLOYEE FREE CHOICE ACT

Sen. Arlen Specter read a prepared statement on the floor of the Senate today pledging to vote against the Employee Free Choice Act, or card check bill, as well as against cloture, which is the procedural move that would open the door for the legislation to come up for a vote. The Republican Senator from Pennsylvania also said that he did not support the EFCA during this time of severe recession, as the legislation would likely result in further job losses.

Specter was likely to be one of the decisive votes in the Senate on EFCA as he was the only Republican to vote for cloture when the measure was last considered in 2007. Organized labor and the bill's Democratic sponsors had been working to secure Sen. Specter's vote to reach the 60 needed in the Senate to avoid a Republican-led filibuster. During his announcement, Specter noted his previous support for EFCA, but suggested that the current condition of the economy makes "this is a particularly bad time to enact employee's choice legislation."

MEXICO APPLIES TARIFFS TO 36 AG PRODUCTS

Western Growers is working with a broad based group of fresh produce representatives urging the Obama administration and Arizona and California's Congressional delegations to immediately resolve the NAFTA Mexican trucking issue that has resulted in retaliatory tariffs being levied by Mexico, including against several fresh produce commodities.

"The administration and our Congressional leaders must resolve this issue with our trading partners in Mexico," said Western Growers president and CEO Tom Nassif. "How can we expect other countries to abide by agreements outlined in trade treaties when we stand in violation of our own international obligations? This issue needs to be resolved for the sake of our industry — an industry that is already suffering from a severe water supply crisis and a recession."

The U.S. department of Agriculture issued a voluntary Global Agriculture Information Network (GAIN) report late last week titled, *Mexico Announces Tariff Modification on 36 U.S. Agricultural Products*.

From the report: The Secretariat of Economy (SE) published on March 18, 2009, in the Diario Oficial (Federal Register) an announcement modifying the import tariffs on 90 U.S. agricultural and industrial products. This announcement was triggered by the dissolution of the U.S.-Mexico Cross-Border Trucking Demonstration Project. From this list, 36 were agricultural products valued at approximately \$864 million. The list of these agricultural products, including the new import tariffs as well the value of these imports (based on Mexico's official data) from 2008 is as follows (click here to read the report and view the complete list in its entirety).

These newly implemented tariffs range from ten to 45 percent on fresh commodities, including a ten percent tariff on onions and lettuce; 20 percent on almonds, dates, pears, apricots, cherries and strawberries; and 45 percent on fresh grapes.

The fresh commodities targeted by Mexico represented more than \$200 million in export value in 2008. These retaliatory tariffs could equate to more than \$2 million per month in excess tariffs that could severely limit exporting to Mexico.

HEAT ILLNESS Q & A DOCUMENT AVAILABLE; UPCOMING TRAINING SESSIONS

After hearing complaints from growers and farm labor contractors concerning inconsistent enforcement of the Heat Illness Prevention Standard (§3395, General Industry Safety Orders) by Cal-OSHA inspectors, the Division of Occupational Safety & Health (DOSH) set out to establish new guidelines intended to inject uniformity into the interpretation of the regulations. The guidelines will be used to train inspectors and may be relied upon by

employers to ensure they are in compliance with the standard.

The Q&A document clarifies the requirements for the provision of drinking water, ready access to shade, and other clarifications regarding Regulation §3395. The document does not modify the regulations in any way but merely serves to clarify DOSH's interpretation of the existing rules and ensure uniform enforcement. In addition, Western Growers and ten other industry groups are introducing "Heat Illness Prevention in Agriculture," a program aimed at combating heat illness injuries in California and giving growers and contractors the tools necessary to comply with the regulation.

PACKER COVERS ANDREW'S, NASSIF'S DC TRIP

As reported here two weeks ago, Western Growers Chairman Kevin Andrew and Western Growers President and CEO Tom Nassif visited Washington, D.C. and met with the Obama administration and members of Congress on a wide range of issues including water, food

safety, immigration and others.

...Nassif said his organization is in favor of expanding the California and Arizona marketing agreements nationally, an idea that was met initially with resistance from grower groups in other states. Now that Congress is revamping food safety legislation and a national good agricultural practices standard is likely, growers in other areas are more receptive to being involved in the discussion.

"We're hopeful that will happen and we're hopeful that if there is going to be legislation, utilize what we have been doing as the produce section of the bill," Nassif said. "Give us the ability to make changes, to make product safer as science evolves and don't force us to make amendments to legislation in order to improve on good science."

Nassif met with Agriculture Secretary Tom Vilsack about a federal water task force. Although the Department of the Interior is taking the lead on plans to alleviate drought effects, the USDA is involved in the process. In a bi-partisan effort, California state legislators are working for an exemption from the Endangered Species Act, which has led to water restrictions to protect a fish, the delta smelt.

"We discussed the loss of jobs, the loss of revenue and many people are moving out of cities because the businesses that were supporting agriculture, or were supported by agriculture, are not doing well since everyone has to cut back so dramatically, especially in the Central Valley, which is the produce basket of the country," Nassif said....

DHS to Eliminate No-Match Rule

Yesterday, the Department of Homeland Security published in the Federal Register its notice of intent to rescind the Social Security No-Match Rule, marking the end of a long legal and regulatory battle over one of the most controversial immigration enforcement efforts of the Bush Administration. Originally due to take effect on September 14, 2007, the implementation of the rule was delayed by litigation led by United Fresh, alongside the U.S. Chamber of Commerce, National Roofing Contractors Association and American Nursery and Landscape Association. The lawsuit was filed on the basis that certain procedures, including an analysis of the law's economic impact on small businesses, were not followed. MORE.

United Fresh Joins Produce Industry Groups in Response to Tribune Residues Story

In a letter to the editors at the *Chicago Tribune*, United Fresh joined other produce industry organizations in clarifying several aspects of the newspaper's August 12 story on pesticide residues.
