USDA CONCORD GRAPE JUICE PURCHASE PROGRAM ANNOUNCED:

The U.S. Department of Agriculture today announced plans to purchase Concord grape juice for surplus removal.

An Invitation for Bid (solicitation) will be issued in the near future for deliveries July 16, 2015 through November 30, 2015. All offers must be submitted electronically through the Web-Based Supply Chain Management (WBSCM) website at

Offerors are urged to review all documents as they pertain to this program, including the AMS Master Solicitation for Commodity Procurements, dated April 2015; any applicable Commodity Specification identified in the subsequent solicitation(s); and the Qualification Requirements for Prospective Vendors, dated October 2014.
