"Producer" means any individual, partnership, corporation, association, or other business unit who:

- A. owns and farms land, resulting in ownership of the English walnuts produced thereon;
- B. rents and farms land, resulting in ownership of all or a portion of the English walnuts produced thereon; or
- C. owns land from which he or she does not farm and, as rental for such land, obtains ownership of a portion of the English walnuts produced thereon.

III. HOW TO VOTE:

- A. Indicate whether you favor or do not favor continuance of Marketing Order No. 984, regulating the handling of walnuts grown in California, by placing an "X" in the appropriate box. *Proxy voting is not authorized.*
- B. Certify your eligibility by completing the Voter Certification and Eligibility Section on the reverse side.
- C. Sign the certification statement on the reverse side. Unsigned ballots will not be counted.
