Nearly 80 agents are currently authorized to certify farms and businesses to the USDA organic regulations. Most USDA-accredited certifying agents are allowed to certify farms and businesses anywhere in the world. Farmers, ranchers, and processors may choose to work with any USDA-accredited certifying agent.



To help narrow your search, this list shows certifying agents that have recently certified farms and businesses in various states. To find a certifying agent that currently works in your state, search for the state either alphabetically or by using your computer's "find" function (usually Control + F). The name of the state will appear at the top of the page. If the state you seek is not listed, then you may want to contact a certifying agent who currently works in a neighboring state.

You should contact individual certifying agents to ask if they are able to certify your farm or business.
