Denver Internation Areo DIA) is approximately 35 miles northeast of the Denver West Office Park. From DIA, generation west on Pena Blvd. (the main road to/from DIA) to I-70 westbound to exit #263 (Denver West Dea.) and turn right after exiting. Turn right again at Denver West **Parkway** and watch for Building 53 (third building on the right).

<u>Parking</u>: Vehicle parking is prohibited at the front of the building (**reserved for patients**). Ample vehicle parking is located on either side of the building. **Park on either side of the building -- not in front.**

<u>Training facility and room:</u> The door to the training room is locked unless it is in use. Normal business hours are 6:30 a.m. to 4:00 p.m. Seating capacity of 45 (classroom style), Plasma screens, In-ceiling speakers and microphones.

One soft drink machine and one snack vending machine are located in the building. There is a full size refirgerator in the room, and coffee will be provided by NOP.

<u>Accomodations:</u> There are no hotels within easy walking distance. There is a Marriott at the intersection of Denver West Blvd., Denver West Pkwy. and I-70. However, we recommend Holiday

Inn Denver West Village, 14707 West Colfax Ave., Golden, CO 80401, 303-279-7611. The hotel is within two miles of the OFO Conference/Training room. There are many restaurants and eateries within easy walking distance of the Holiday Inn. The Colorado Mills Mall is across the street from the Holiday Inn and there are also places to eat there as well. Directions to the hotel are: follow the directions from I-70 westbound, except turn left onto Denver West Blvd. after exiting. Move over to the right lane as you will make a right onto Colfax within 1/3 of a mile. Watch for the Holiday Inn on your right. You will encounter the first entrance before you get to the intersection of Colfax and Indiana streets. If you miss the first entrance, you can turn right on Indiana and enter that way.
