He feels that it would helpful and would incentivize the industry to move away from this material, which they have indicated they wish to do. The CS Chair reminded the group that checklists for the sunset materials are optional, and suggested that instead of completing a full checklist, the lead could extract the information and write it in narrative form in the summary, expanding the paragraph that was provided. The members chose to defer the vote until this is completed.

The CS Chair noted that she will not be available on the next CS call, and asked that the Vice Chair be prepared to lead the discussion and vote for this material. She also asked that the boiler plate language be added to the draft document indicating that the CS is voting to remove based on OFPA criteria. A member added that since there was a TR contracted, perhaps it makes sense to include an abbreviated checklist as well as a summary of the public comment. He also suggested that since the industry would like to move away from using this material, that info should be highlighted in the review. Members agreed that if there is no new info for a material then they do not need to complete a checklist.

- 2016 Sunset Ferric Phosphate (CBe). The lead noted that she will revise the ferric phosphate review to be consistent with other 2016 reviews. A member added that there was some additional info included in the last review about the concerns over EDTA, and urged that it be included here. This he feels, will create incentives to move away from this material. The lead will add the additional information and the group will defer the vote until the next meeting.

A member provided a checklist for this material.
  - Oils (horticultural): Two members collaborated on a checklist for this material, with additional questions for posting, including a question about the definition of the "narrow range". A member noted that there are horticultural oils that fall just outside the definition of "narrow range". The CS Chair indicated that the best way to address this would be via a regulatory change.
  - Pheromones Synthetic insect hormones that are used to disrupt mating or for monitoring.
     Some inerts are listed in the TR. Members discussed the questions in the draft document, and the Chair noted that they should include some questions about new delivery systems that are

currently being developed. The lead will make some edits based on suggestions. The Chair also mentioned microencapsulated pheromones as they were discussed in the TR, however these are not being used in organic agriculture because they have list 3 inerts, and are not used in passive dispensers.

## Discussion

- Crops Subcommittee notes of January 20, 2015 were approved with no changes
- 2017 Sunset: Lime Sulfur (HA) Lime sulfur is listed as an insecticide and fungicide. The CS received a new TR and the lead conveyed to the group that it was very thorough and well done. The CS found it sufficient. Members discussed future iterations of TRs and perhaps altering or adding some questions regarding efficacy of alternatives which will aid in their review..
- 2017 Sunsets: Ash from manure burning, Tobacco dust (nicotine sulfate), Arsenic (CBo) All are 205.602 materials; Non synthetics prohibited. The draft review docs were sent out prior to last meeting, and included checklists. The lead did not propose any additional questions.
- 2017 Sunsets (CBe)
  - o **Aquatic plant extracts -** The lead summarized past reviews and recommendations, and noted that there was a 1995 TAP and a 2006 TR. There are no concerns with this material.
  - Humic acids The lead summarized past reviews and recommendations, and noted that there
    was a 1995 TAP and a 2006 TR. The CS Chair added that the TR for oxidized lignite addressed
    humic acids, and feels that it should be referenced in this review. The CS Chair offered that

some groups in the organic community feel that not all humic acid derivatives are synthetic, and as such she feels this material could be a candidate for an annotation change. NOP noted that classification issues can be clarified in the Materials Classification guidance (not yet finalized).

- o Lignin sulfonate (petition to remove and sunset) deferred to next call.
- Liquid fish products The lead summarized past reviews and recommendations, and noted that there was a 1995 TAP and a 2006 TR. The CS Chair added that the annotation is problematic for use in review of blended fertilizers containing liquid fish. ZS will write a question for addition to the document.
- Micronutrients Found to be essential. Members discussed the annotation, which restricts use and requires testing for deficiency, and will add a question about the various ways to document deficiency.
- Magnesium sulfate The lead summarized past reviews and recommendations, and noted that there was a 1995 TAP and a 2011 TR. There was a unanimous vote in 1995 that Magnesium sulfate is synthetic and inconsistent with organic production, but based on public comments that there were no alternatives, the Board reconsidered its recommendation. The CS will include some additional questions for posting.
- 3-decene-2-one (CBe) Petitioned Material. This material is a registered pesticide. The lead
  incorporated comments from JFe into the document after the last call, and the group proceeded to a
  vote.

- Hydroponics/Aquaponics task force. The CS Chair informed the CS of the NOPs intention to create a
  Hydroponics/Aquaponics task force. The call for nominations will be published in the next few weeks
  and will be open for 60 days. In addition to the CS Chair, who will act as liaison to the Board, the chair
  invited another NOSB member to self-nominate if interested. The task force will report to CS and will
  present their findings at the spring 2016 NOSB.
- 2017 Sunsets (CBo)
  - o **Ammonium carbonate.** Used in traps, so no contact with organic food, soil, etc. The CS will not pose additional questions
  - Newspaper or other recycled paper. Used as mulch and compost feedstock. The CS will include some questions about inks.
  - Plastic mulch and covers. Herbicide, weed barrier. Members discussed the inclusion of
    questions and whether or not it would be useful given the recent memo from the NOP
    regarding the bio-based bio degradable mulch. The memo clarifies that currently there are no
    products that would qualify as bio-based, biodegradable based on the percentage of biobased

components versus petroleum based components. The CS Chair noted that plastic mulch is currently the only alternative.

- **2017 Sunsets Potassium bicarbonate** (HA) Limited scope TR was requested and received. The TR was found sufficient, as it answered the two questions that were posed by the HS. However, the lead feels that it did not provide comprehensive information on the many uses for disease control, so the HS will seek the additional information via public comments.
- 2017 Sunsets Hydrogen peroxide (ZS) The 2006 notes indicate there was a TR, but the CS Chair was not able to locate this document, if it exists. NOP note: The NOP verified that there was no TR, only the 1995 TAP. The 2015 TR was found sufficient and the CS will add questions to the posting regarding the use of hydrogen peroxide to fight fireblight.
- **2017 Sunsets Herbicides, soap-based** (FT) The TR has not been received yet, so the CS will defer to next call.

  the lead posed, but the CS had a couple of other questions to add to the posting. The CS Chair noted
  that public comment would be useful but suggested that a Limited Scope TR would be helpful in the
  future.
- 2017 Sunsets (CBo)
  - o **Sticky traps/barriers.** The CS will pose questions for the first posting in spring 2015.
  - Microcrystalline cheesewax. Petroleum product. Alternatives may be available. The CS will
    pose questions for the first posting, and discussed need for future limited scope TR for the next

- O Boric Acid. The Subcommittee will add questions for public comment. Group members asked that any declarative statements regarding the material (e.g. 'the substance is toxic') have citations. Many members felt that this type of language does not belong in the first posting for a material, but instead could be included in any attached checklist. Some members pointed out the references were limited and not scientifically rigorous.
- 2017 Sunsets Vitamin B1, Vitamin C, Vitamin E (CBe). There was a 1995 TAP and the CS is waiting for a new TR. The CS will not add additional questions outside of the standards questions that the NOP included in the template.
- 2017 Sunsets Ethylene (HA). Listed at 205.605k (synthetic substance). Used to initiate pineapple
  flowering. No new TR was contracted; the most recent is from 2011. Questions will be related to use by
  smaller growers, and current practices. One member asked about environmental impacts of this
  substance.
- **Contaminants in Farm Inputs (CBo)**. The draft document was sent immediately before the call so the group deferred the discussion until others had a chance to read it.
- 2017 Sunsets Coppers (fixed), Copper sulfate (ZS). The CS Chair created her own review form as she felt the checklist format was not conducive to this review. The alternative form was composed with criteria directly taken from OFPA. The CS will add several questions for public comment. A member asked about contamination in water runoff, which she also noted is regulated under the EPA and Clean Water Act. The Chair noted that that is more of a concern for copper used in rice production. She also noted that copper accumulation varies greatly, but under current organic management practices it should not accumulate.
- **2017 Sunsets (ZS) Inerts** The CS received a limited scope TR on nonylphenols, a subset of Inerts. At this time the group will provide a document that includes information about the collaboration between the NOSB/NOP and EPA, and what the intention is moving forward.
- **2017 Sunsets Lignin sulfonate (CBe).** CBe will review additional information supplied to her by JR. A separate petition to remove lignin sulfonate as a floating agent was sent to the NOSB. Discussion on this will be delayed to a later meeting since it is not on the April agenda.

- **Crops Subcommittee notes** of June 2 were approved with minor changes to the voting on microcrystalline cheesewax and a clerical error.
- Sulfuric Acid (FT) The lead summarized the petition for the group and added that although the
  petition was lengthy it did not include information about essentiality. Sulfuric Acid is used for
  manufacture of micronutrients. Based on information in the TR he notes that this material is not
  compatible with organic principles and does not support a holistic approach. The petition was found
  sufficient, and no TR will be requested. The lead will prepare a proposal and the HS will discuss it on the
  July 21 call. Another member noted that Anaerobic Digestate, which was recently petitioned, is treated
  with sulfuric acid in large quantities. The HS discussed Anaerobic Digestate briefly and will discuss it

further on a later call. The NOP suggested that the HS may want to request a TR for Anaerobic Digestates.

  the current revisions.
