USDA AMS NATIONAL ORGANIC PROGRAM COST-SHARE PROGRAMS REPORT TO CONGRESS

A. BACKGROUND

The U.S. Department of Agriculture's (USDA) Agricultural Marketing Service (AMS) National Organic Program (NOP) administers two organic certification cost-share programs. Each program provides cost-share assistance, through participating States, to organic producers and/or organic handlers. Recipients must receive initial certification or continuation of certification to the USDA organic regulations from a USDA-accredited certifying agent. Reimbursement is currently available at 75 percent of an operation's certification costs, up to a maximum of \$750 per year.

The first program is the Agricultural Management Assistance (AMA) Organic Certification Cost-Share Program, which was established in 2001 as part of the Agricultural Management Assistance Program. This program is authorized under Section 1524 of the Federal Crop Insurance Act, as amended (7 U.S.C. 1501–1524). It authorizes cost-share assistance to producers of organic agricultural products in Connecticut, Delaware, Hawaii, Maine, Maryland, Massachusetts, Nevada, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Utah, Vermont, West Virginia, and Wyoming. AMS allocated \$1.425 million to States in fiscal year 2012; States will distribute these funds to producers in fiscal year (FY) 2013.

The second program is the National Organic Certification Cost-Share Program, which was re-established as a part of the Food, Conservation and Energy Act of 2008 (7 U.S.C. 6523). This program was initially established as a part of the Farm Security and Rural Investment Act of 2002 (7 U.S.C. 3007). It authorizes cost-share assistance to producers and handlers of organic agricultural products in all States and U.S. Territories (hereafter known as "States"). In FY 2008, Congress provided, on a one-time basis, \$22 million for this program, to be allocated to States until the funds are exhausted. To prevent duplicate assistance payments, producers participating in the AMA program are not eligible to participate in the producer portion of the National program.

AMS invited State agencies to participate in cost-share programs through Federal Register Notices, Grants.gov postings, electronic communications, and personal phone calls. A Notice of Fund Availability was published for both programs in the Federal Register (78 FR 5164-5165), and the NOP posted the notice and an accompanying newsletter article on its Web site. The funding opportunity was also posted on Grants.Gov. As of February 2013, the States had distributed approximately \$20.3 million of the \$22 million allocated for the National Organic Certification Cost-Share Program.

B. FY 2013 PARTICIPATION AND FUNDING OBLIGATIONS

15 of the 16 eligible States are expected to participate in the AMA cost-share program for FY 2013, as shown in the map below; AMS allocated these funds to the States in FY 2012. Detailed enrollment and allocation data are outlined in Table 1 in the appendix.

 Application instructions and cooperative agreements for FY 2013 were sent to the 16 AMA program eligible States. All but Utah are participating in the program. The Utah Department of Agriculture and Food chose not to submit an application to participate in either cost-share program, citing inadequate staff resources to manage it.





- For the FY 2013 AMA program, \$1.425 million is available to States for costshare assistance.
- State agencies are required to submit requests for disbursements to receive funds.



C. SUMMARY OF FY 2012 AGRICULTURAL MANAGEMENT ASSISTANCE COST SHARE PROGRAMS FUND USE

- Using cooperative agreements, AMS allocated \$1.5 million to States for the AMA program in FY 2011; States distributed these funds to producers in FY 2012.
- Table 2 lists the total cost-share assistance payments provided by States to AMA-eligible organic operations certified between October 1, 2011, and September 30, 2012 (FY 2012).
- As of January 31, 2013, AMA program States had provided \$1,296,208 in cost-share assistance to 2,348 organic producers, an average payment of \$552.
- 10 States provided more funds in cost-share assistance during FY 2012 than FY 2011, and two States provided funding at approximately the same level. Utah and Wyoming did not participate in the FY 2012 AMA program.

D. SUMMARY OF NATIONAL PROGRAM FUND USE IN FY 2012

- Table 3 lists total cost-share assistance payments provided through the National Cost-Share program to organic operations certified between October 1, 2011, and September 30, 2012.
- In FY 2012, \$6,603,200² was allotted through cooperative agreements to the participating States.
- As of January 31, 2013, National Program States provided \$5,309,783 in costshare assistance to 7,245 organic producers or handlers, an average payment of \$733. Final reports are pending from 2 States: Kentucky and Indiana.
- Unused funds or funds returned by States were reallocated to States through amendments to the FY 2012 cooperative agreements. 10 States requested fund increases during FY 2012.
- 28 States provided more funds in cost-share assistance during FY 2012 than FY 2011, and one State provided funding at approximately the same level. Two States and three territories did not issue any reimbursements in the FY 2012 National program: Guam, Puerto Rico, Utah, West Virginia, and the U.S. Virgin Islands.

² The allotment has increased from the amount previously reported in the 2012 Report to Congress due to reallocation of unused State funds from the prior fiscal year to meet demand.
