## **Fresh Products Branch Bulletin**

FPB 02-2IDENTIFYING TOMATOES FROM FLORIDA WITH PLI MARKS THAT ARE NOT01/30/02CERTIFIED FOR STANDARD WEIGHT AND THAT ARE PRODUCER FIELD-<br/>PACKED TOMATOES

- I. Purpose This bulletin identifies Positive Lot Identification (PLI) markings for Florida tomatoes that are not certified for standard weight and Florida tomatoes that are producer fieldpacked.
- II. Background Prior to the 2001-2002 Florida tomato season, the Marketing Order for Florida tomatoes was revised. The impact on the inspection service was to add a designation to the PLI marks so that such lots can be identified at terminal markets. The following provides an explanation and identifies the PLI designations:
  - (1) Yellow flesh tomatoes and one- and two-layer place-packed tomatoes are exempt from container standard weight requirements at shipping point. However, all other requirements of the Marketing Order must be met. To better identify the exempted lots, the designation of "C" will be added to the PLI numbering scheme, and will be referenced such as "USDA/FL 123 AA/C" or "USDA/FL 123 AA-C" for example.
  - (2) Producer-field packed tomatoes are picked and place-packed in new containers in the field by a producer and transferred to a registered handler's facility for further preparation for market. These tomatoes must meet all requirements of the Marketing Order for Florida tomatoes with two exceptions: (a) the tomatoes must be turning or higher color at the time of inspection; and (b) the tomatoes may be 2-17/32 inch minimum (with no maximum) only if containers are marked "6x6 and larger." To better identify these lots, the designation of "F" will be added to the PLI numbering scheme, and will be referenced such as "USDA/FL 123 AA/F" or "USDA/FL 123 AA-F" for example.

For purposes of determining size on producer-field packed tomatoes, those marked "6x6 and larger" will be considered as meeting Marketing Order requirements if undersize does not exceed the off-size tolerance for the minimum 6x6 size. No maximum size is required.
