## **Checkloading Study**

### Data from 2046 loads of USDA Product Checkloaded by 12 SCI Offices February and March 2014





## **Checkloading Study Defects**

- Carrier Condition: Holes in carrier, or doors could not be locked/sealed.
- Condition of Cases: Dirty, torn, or wet.
- Condition of Primary Container: Cans, bottles, or cartons out of condition (e.g., dents, rust, torn, etc.).
- **Count:** Number of containers incorrect.
- **Pallets:** Pallets damaged (e.g., broken boards) or product was not unitized on pallet.
- **Temperature:** Product or carrier did not meet temp. requirements.
- Wrong Codes: Product codes were not on the list of approved codes.
- 14-Day Hold: Not met.
- Other: Wrong seal type or errors on contractor's shipping orders.



## **Checkloading Study - Data**

## **Certificate of Quality and Condition**

- 2 weeks to 12 months (canned dried and dehydrated). Open 1/3 rate and update certificate
- 12 months or more (canned dried and dehydrated) or 6 months (frozen) complete inspection required
- Former AMS purchase for canned product 90 days

If no obvious change to lot is observed, F&V will consider accepting certificates for canned product within 12 months from time of original certification without additional sampling of lots.
