I am writing to request information for our preparation for an upcoming hearing. As we are preparing our position we need some data from your staff for the upcoming Order 33 hearing. We are interested in receiving your responses to any other requests. The purpose of this request is to supplement, not require duplication of, your earlier efforts. We would like your staff to prepare the following:

- 1. Jan 2003 to current Monthly pounds of milk delivered to distributing plants within 50 miles of St. Louis, MO from producers located outside of FO #32.
- 2. Fluid milk sales in FO # 32 from plants regulated by FO #33.
- 3. Monthly pounds of milk pooled on FO #32 but diverted to plants located inside the FO #33 marketing area for Jan-03 to the present.
