Sunset of Microorganisms

I. List:

National Organic Program Subpart G: The National List of Allowed and Prohibited Substances. §205.605 Nonagricultural (nonorganic) substances allowed as ingredients in or on processed products labeled as "organic" or "made with organic (specified ingredients or food group(s))."

a. Nonsynthetics allowed

II. Committee Summary:

Microorganisms were first petitioned on 12/10/02 and added to the National List §205.605(a) effective on September 12 2006 by Final Rule TM-04-01FR based on the NOSB recommendation of May 1, 2003..

Microorganisms are essential for the production of many fermented foods. Prominent cultures include Acetobacter (vinegar), Aspergillus Oryzae (miso), and Rhizopus (tempeh)

The TAP review of October 8, 2002 reviewed microorganisims. Previous TAPS had reviewed dairy cultures (1995), yeast (1995), and enzymes (2000). The TAP stated that there was no need to review microorganisms individually. The TAP review determined that microorganisms were not synthetic, met fully the criteria for §205.605a and should be included on the National List. Finally, the TAP did not identify any unacceptable risks to the environment, human or animal health resulting from the use or manufacture of microorganisms.

The NOSB has received 7 public comments in support of the relisting Microorganisms in response to the Federal register notice of the sunset of Microorganisms (AMS-TM-07-0136). No public comments have been received opposing the continued use of Microorganisms in organic handling.

III. Committee Recommendations

The Handling Committee recommends the continued listing of Microorganisms on §205.605(a).
